MemberCare Online Insurance Quoting services campaign

1. The Promotion is for MemberCare Online Insurance services purchased through Australian Defence Credit Union (ADCU).
2. Information on how to participate in the promotion forms part of these terms and conditions. Participation in the promotion is deemed acceptance of these terms and conditions of eligibility.

4. The Promotion Period commences at 9:00am on 8th February 2010 and closes at 5pm on 30 April 2010.
